#### <u>USH Officially Acquires</u> <u>Solar Equipment Behind the</u> <u>Meeting House</u>

On June 30<sup>th</sup> USH became the owner of the solar equipment located at the rear of the Meeting House. This ended a process first begun in 2015 when a group of USH members began a process to acquire the solar equipment and benefit by the then state and federal incentives for purchasing and installing such solar equipment. After studying tax law and assembling other relevant information, the group found it could only benefit from the incentives if a tax paying owner was

involved. Consequently, David Newton became a Sole Proprietor and through a complex series of agreements with USH (Endowment) leased the land under the equipment from USH and provided solar electricity to USH at a cost slightly less than Eversource would charge for the same amount of electricity. In addition, ZREC (state incentive payments) for solar electricity generated onsite were paid to USH further reducing the cost of Kilowatts used in the building.

Member donations to the Endowment were loaned to the Sole Proprietor to finance the purchase and installation of the solar equipment while the Sole Proprietor paid interest on the funds benefitting the Endowment as would any other similar invested funds.

After a five-year interval, USH has now purchased the equipment and the Sole Proprietor paid off the remaining balance on the outstanding loan as well as outstanding lease costs. In the end, this process resulted in a reduction in cost of electricity used by USH over the five-year interval and now, an annual reduction of the cost of electricity used in the Meeting House to close to zero for at least the next 15 years. On an annual basis, the Meeting House consumes about the same amount of electricity the solar equipment produces.

#### **RETURNING TO SCHOOL 2021-22**

Returning to school in the Fall can be an anxious time for children and their families, never more than this year. Children are returning after a yearlong pandemic; classes have been in person, online or hybrid. The world around them has been chaotic, with lives lost to the pandemic, an

uncertain economy, and stress. School opening has become a flashpoint in the reopening of our country. For the past eight years the Unitarian Society of Hartford has helped children in Greater Hartford return to school by supporting the Uniform Fundraiser at The Village for Families and Children.

This Fall, Hartford Schools will be fully open, with all in-person classes. Hartford Public Schools require that students wear school uniforms - for example, students who attend Burns school must wear blue tops (tee shirts, sweaters) and black bottoms (pants, skirts, leggings). Uniforms help diminish visible inequalities between students – the pandemic has only increased these inequalities. ### When the Unitarian Society of Hartford Website Became a "Porn" Site The Rest of the Story

Friday, April 11, 2003 On toward 7 PM the first call arrived. "Do you know, our website has porn on it?" After a quick check of the computer, website is normal, what is happening? Probably just some internet screw up. A few minutes later, another call, same concern, porn on the website. Time to check the home computer again. Wow, the normal website has been replaced with porn pages!

Quick, call the internet service provider. What on earth is happening? Delay, as usual, to finally contact a human. "Just a minute while we check......Oh, your domain name has been purchased by a German outfit."

With mounting trepidation, "How can that be?"

"You never paid the bill to renew your ownership of the domain ushartford.org. We have been sending the bill (\$15) and nobody paid it after weeks of notice that the ownership would expire."

Fact check.. subsequently, we learned the USH office person at the time simply failed to worry about this minor bill that had arrived...

The internet was relatively undeveloped back then by today's standards. As it happened, the USH Communications Committee met with then Minister Terasa Cooley about creating our first website. The scheduled date for that meeting was 911, yes, the very day when the World Trade Center was aflame at the time the meeting was convened. The result of the meeting was a determination for David Newton to create a new USH website and associated email distribution lists for those who had computers a relatively small percentage of the congregation at that time.

Early development of the website involved purchase of a domain name. The domain name ushartford.org was selected as we were a charitable institution. And thereafter, we were off on the adventure of publishing the paper Messenger, print, fold mail, and off to the post office, for most of the congregation, and also sending USH-Enews to those few who had computers. But, band width was limited, however, you could include an occasional picture (just one) with your electronic news email.

By 2003 the readership of the USH-Enews by electronic means was increasing as the number of hard copies of the Messenger was going down, and the transition saved postage and printing costs as well!

Now, here is how domains work. If you create one that does not exist anywhere in the world, you can have it for the normal annual fee. And, if one previously owned is lapsed, you can buy it and use it. The normal convention is those ending with .org represent charitable organizations and those using .com represent businesses of various sorts. There are other alternatives as you probably have observed, .net for example.

Thus, on the evening of April 11, 2003, having lost our .org domain, we went shopping for a new one under emergency conditions. As it happened, .com was available and we purchased it immediately and set about changing the web assignment, and all associated email connections to the new domain, ushartford.com. This process was occurring even as the old address was being reassigned to the porn site all over the world. A process that takes from 20 minutes to a day or so. As the USH mailing lists were about to vanish forever, we sent one final email to all subscribers on various lists. We informed them that when you seek to work with ushartford electronic addresses and the web tomorrow, all addresses shoud be changed ushartford.com! And that was the last communication from the purchased domain, ushartford.org. This activity finished up around 4 AM on Saturday morning and related activity continued through that day.

The congregation got an explanation on Sunday!

You might ask, could we have bargained with the new owner of ushartford.org to get the domain name back? Yes, I trust you understand ransomware, it would be sort of like that!

Time passed. You can always check on available domain names and we did so from time to time. "Our" domain in Germany latter showed up with an owner in Panama, and still later elsewhere in the Caribbean. After the porn first use lost its value, other sales-related uses occurred. Then, major excitement, a random check in 2008 found the domain available for purchase. With quick and trembling keystrokes, we purchased it and it has been back with us to date, but not used as it would be difficult to change all those .com users and uses to a different domain.

Now, because of spam issues, we are moving email boxes associated with USH to Gmail. Because it is a large provider of email services, communications are unlikely to be stopped because of spam suspicions by other companies' email software. And in connection with that and various related changes, **our web address has returned to ushartford.org** properly reflecting our institutional status.

However, if you were to request the web address as ushartford.com, net or certain other group designations, we now own some of them as well. You would be transferred immediately to ushartford.org.

What ever happened to ushartford.org and how come it is back?

Now you know, and that, is the rest of the story.

#### Mysterious disease that kills birds spreading

Whatever has been killing thousands of birds in the Southern and Midwestern states has now spread to the East Coast. The cause is unknown, and the threat so severe that the Connecticut Audubon Society, working closely with the state Department of Energy and Environmental Protection, is recommending that residents remove birdfeeders from their yards.

The unnamed menace, currently best described as a "potential disease," has killed thousands of birds, starting in some Southern states, then in the Midwest and now toward the East Coast. It is uncertain whether the disease has spread to Connecticut yet. The Audubon Society says there have been reports of dead birds, including in Hartford, but that many of them don't line up with the symptoms found elsewhere.

The society itself has removed birdfeeders at its own centers, something it has rarely done; the last time was during the spread of House Finch eye disease several years ago.

Asking that feeders be taken down is not a decision that was made lightly, says Connecticut Audubon Society's Executive Director Patrick Comins. "It's detrimental to us. We sell a lot of bird seed. It's an important source of revenue for us."

Bird baths, hummingbird feeders and other objects which attracts birds should also be removed.

The Audubon Society suggests you bring the feeders and baths indoors and clean them thoroughly with a 10% bleach solution.

Removing feeders lessens the amount of contact among birds of different species and can slow the spread of a fatal problem about which very little is known. Otherwise, with the fall migratory season approaching, the mystery ailment would spread must faster and further — even from Connecticut to the tropics, Comins fears.

The condition is so far limited to songbirds, but "migration is starting now, with shore birds coming toward us. It will be very troubling if we start to see this in shore birds."

Comins says hummingbirds may be affected, but it is difficult to locate dead hummingbirds because they are easy prey for other birds and animals.

Audubon and DEEP follow Pennsylvania, Indiana, Ohio, all of which advised the removal of birdfeeders.

Dead birds found in other states have been tested for "every known pathogen of birds," Comins says, "and nothing has been found. Toxicology tests are also being done, and those can take longer."

Among the known bird diseases and viruses that have been ruled out so far are salmonella, avian influenza, West Nile virus, Newcastle disease viruses, herpes and pox viruses and Trichomonas parasites. "We haven't ruled out pesticides," Comins says. "One of the initial hypotheses was that the

deaths corresponded with cicadas that had been sprayed. Or this could be a novel pathogen that we haven't seen before."

Whatever the cause, "it's terribly worrisome," Comins says. "We don't know how it's being spread. A novel disease that takes time to isolate and cure or contain could have a sharp and immediate impact, since the affected birds eat and control pests that might breed more heartily otherwise."

#### What to look for:

The birds most commonly affected include the American robin, blue jay, common grackle, yellowtail flicker, European starling, northern cardinal, house finch, house sparrow, Eastern bluebird, red-bellied woodpecker, and Carolina wren.

When you see a dead bird, check its eyes. If the eyes look swollen or cloudy or have a crusty discharge, notify DEEP.

If you see more dead birds than usual in a certain location, notify

DEEP.

#### What to do if you find an infected bird

If the bird is alive, contact a state appointed rehabilitator. Information on rehabbers in various parts of the state is at

<u>portal.ct.gov/DEEP/Wildlife/Rehabilitator/Dealing-with-Distressed-Wildlife.</u>

Take a photograph of a dead bird from a safe distance, focusing the camera on the bird's eyes. Send the photo to the DEEP.

Dispose of the bird. Don't touch it with your hands: use disposable gloves or cover your hands with a plastic bag. Double-bag it so that it can not affect other birds or animals, then put it in the trash.
