

From the Board

We were hoping to report some good news from our ministerial quest, but that now needs to wait a while. Here's the condensed version: we had two Zoom interviews, with predominantly positive impressions all around; references were provided and verified; we made a verbal offer... which shortly thereafter was declined with regrets.

Needless to say, this was disappointing.

Here are relevant paragraphs from the email we received:

"I am deeply grateful for your invitation to serve, but I have decided not to take an interim position this fall.

It has been a joy to meet you, and, while I think some of the challenges you face are daunting, I think that a seasoned minister with a clear sense of the "interim task" would enjoy working with you. It is clear that you are a strong congregation.

The decision to choose not to take an interim position at this time is a reflection of my personal situation. When the time comes, I hope a future minister in Hartford will invite me to come and preach for you and to meet you IRL (in real life) as it were.

I hold you and your congregation in my humanistic prayers and Universalistic heart."

Now, it's back to the drawing board. Our primary interface with UUA's transitions office, Rev. Keith Kron, is out of the office this month. Eve has again reached out to the UUA, and has heard that they are working to connect us with other prospective candidates.

Congregational Matters

Important Congregational Hearing on July 17

What for? On Sunday, June 12, the Building and Grounds Sub-council (B&G) voted 12-0 to move forward a process for informing the congregation of benefits and process for pursuing a nomination of the Unitarian Meeting House to the National Register of Historic Places. The first step will be a hearing on the matter occurring after the service on

July 17th. The outcome of the hearing will determine next steps, if any. You can read more from the published article <u>HERE</u>.

Where is the hearing? The hearing will be in Fellowship Hall about 5 minutes after the service also occurring in Fellowship Hall.

What is the purpose? To inform the congregation, receive questions, accept opinions, and generally discuss the matter.

So, what do I know? You can know quite a bit. You can follow the link above. And, you can find further information with **this one**. In addition, a full brochure explaining the National Register is currently posted on the wall of the Ambulatory adjacent to the office. It may be moved subsequently to Fellowship Hall.

The B&G sub-group guiding this matter consists of Toni Gold, Jim Venneman, and Laura Cipriano. They look forward to discussing the project with you.

USH's Banner Project!

Last winter, Evan Williams and Sue Smolski began to focus on our USH banners from two very different perspectives. Evan (in photo, right) came with an intense wish to quiet the swaying and soft clattering of those banners on the sanctuary walls that



hang above the heating registers. Sue arrived with a strong desire for organized archival information about our numerous banners.

Evan approached the Building and Grounds Sub-council, proposing clear, air-deflector covers be installed over the heating vents. She also secured the affected banners by inserting dowels or slats in channels along their lower edges, providing extra weight and stability. Meanwhile, Sue was mulling over the process of creating Archival Information Documents and knew the Chancel Artists would be a good place to start.

It may have been right after a service, or at Coffee Hour, that a mutual

interest in our banners was discovered and a working team was created. A thorough inventory of all our banners has now been completed. Further, we have a timeline for the rest of the Archival Project and will share this in the eNews next month. We will seek information from the congregation early in the fall, regarding the origin, purpose, and history of some still unprovinanced banners.

More immediately, Evan's additional focus on refurbishing any banners in need is in the spotlight. We wanted to let everyone know that the banners on the front lobby walls in the stairwells will be taken down (thank you, Kevin). Evan will refurbish the Accessibility Banner and clean the White Tapestry banner (see photos below).


