The National Register of Historic Places: Meeting Summary, Part I

An information session/hearing, about the prospect of seeking designation of our Unitarian Meeting House as a "national historic place", was held on Sunday, July 17. A Building and Grounds sub-group comprising Toni Gold, Laura Stewart Cipriano, and Jim Venneman has been working on this project for several months, researching potential benefits and drawbacks, if any, of such a designation. Last Sunday they, joined by Mary Falvey (Executive Director of the Hartford Preservation Alliance) shared their findings with approximately 50 members of the Society (in person and via a Zoom connection). Comments and questions were then solicited.

Questions were plentiful and wide-ranging. This week and next, we will replay (in print) salient points covered, attempting to consolidate this information by general topic. Here goes...

1. What is the National Register of Historic Places?

The National Register of Historic Places is the official list of the nation's historic places worthy of preservation. Authorized by the National Historic Preservation Act of 1966, the Register is part of a national program to coordinate and support public and private efforts to identify, evaluate, and protect America's historic and archeological resources. 2. How is the Meeting House qualified?

The Meeting House is an outstanding example of the mid-centur modern architectural style, and is designed by a distinguished architect, Victor Lundy. Now that it is over 50 years old, it has become eligible for listing in the National Register.

Once a detailed research account has been written and accepted by the

Connecticut State Review Board, that board will then forward the nomination to the National Register of Historic Places of the National Park Service, which will officially list it. This action automatically also places it on the Connecticut Register of Historic Places and brings it under the jurisdiction of Hartford's historic preservation ordinance. The National

Register was created in 1966 to protect historic structures, which were being destroyed wholesale in cities all over the country by construction of the Interstate Highway System.

3. How much would it cost us to achieve this designation, and how long would it take?

The Hartford Preservation Alliance, of which Mary Falvey is the executive director, has proposed for a fee of \$1500 to help us prepare a funding request for \$15,000, for a consultant who would actually research and write the detailed National Register nomination. If funded, Ms. Falvey would help us select such a consultant — an architectural historian on the state's approved list — to do the research and writing and guide us in an appearance before the state preservation review board. The entire process generally takes about two years.

4. Would the designation allow us to access funds through grants?

Yes, matching grants are available (up to \$200,000) from Connecticut's Historic Restoration Fund. These matching grants require the grantee initially to finance the full cost of a project and then request reimbursed at the 50% level up to the grant's maximum allowable amount. Depending on the magnitude of the project, it may be possible to fund the entire amount with a single grant, or to plan the project in phases over a longer period, applying for successive grants.

We will get more into the nuts, bolts, and financial ramifications in the next segment of this synopsis. There will be more discussion before anything is moved forward, but it's important to become familiar with the process and its advantages. Many thanks go to the group who spent months learning and preparing for this presentation, and particularly to Toni Gold for capturing the essence so clearly.

And, one final question for today:

5. Who owns the Meeting House?

We do!!! The Unitarian Society of Hartford owns the Meeting House. You can view the City of Hartford's property record online, and see for yourself.






